Introduction

The Replacement 40 VA Transformer M3069 is used with the Switching Relay 304P and 306P or the Zone Valve Control 304V and 306V to increase VA capacity or replace a faulty transformer.


Installation

The M3069 can replace a faulty transformer on the Switching Relay 304P or 306P or the Zone Valve Control 304V or 306V.

Alternatively, the M3069 can be installed in the left side of the 304P, 304V or 306V to increase the power supply to 80 VA.

Steps:

- 1. Disconnect power before opening the enclosure cover.
- 2. Remove the faulty transformer (if required):
 - a. Disconnect the electrical connector from the control (see figure, location 3).
 - b. Remove screw (see figure, location 2).
 - c. Slide transformer down or up to free the transformer mounting tab (see figure, location 1).
- Install the new transformer:
 - a. Slide transformer mounting tab under the metal enclosure pocket (see figure, location 1).
 - b. Install screw (see figure, location 2).
 - c. Install transformer electrical connector to the 304P, 306P, 304V or 306V electrical socket (see figure, location 3). The socket can only be installed one way to ensure correct electrical connection.
- 4. Close enclosure cover and reapply power.

Limited Warranty and Product Return Procedure

Limited Warranty The liability of tekmar under this warranty is limited. The Purchaser, by taking receipt of any tekmar product ("Product"), acknowledges the terms of the Limited Warranty in effect at the time of such Product sale and acknowledges that it has read and understands same.

The tekmar Limited Warranty to the Purchaser on the Products sold hereunder is a manufacturer's passthrough warranty which the Purchaser is authorized to pass through to its customers. Under the Limited Warranty, each tekmar Product is warranted against defects in workmanship and materials if the Product is installed and used in compliance with tekmar's instructions, ordinary wear and tear excepted. The passthrough warranty period is for a period of twenty-four (24) months from the production date if the Product is not installed during that period, or twelve (12) months from the documented date of installation if installed within twenty-four (24) months from the production date.

The liability of tekmar under the Limited Warranty shall be limited to, at tekmar's sole discretion: the cost of parts and labor provided by tekmar to repair defects in materials and / or workmanship of the defective product; or to the exchange of the defective product for a warranty replacement product; or to the granting of credit limited to the original cost of the defective product, and such repair, exchange or credit shall be the sole remedy available from tekmar, and, without limiting the foregoing in any way, tekmar is not responsible, in contract, tort or strict product liability, for any other losses, costs, expenses, inconveniences, or damages, whether direct, indirect, special, secondary, incidental or consequential, arising from ownership or use of the product, or from defects in workmanship or materials, including any liability for fundamental breach of contract.

The pass-through Limited Warranty applies only to those defective Products returned to tekmar during the warranty period. This Limited Warranty does not cover the cost of the parts or labor to remove or transport the defective Product, or to reinstall the repaired or replacement Product, all such costs and expenses being subject to Purchaser's agreement and warranty with its customers.

Any representations or warranties about the Products made by Purchaser to its customers which are different from or in excess of the tekmar Limited Warranty are the Purchaser's sole responsibility and obligation. Purchaser shall indemnify and hold tekmar harmless from and against any and all claims, liabilities and damages of any kind or nature which arise out of or are related to any such representations or warranties by Purchaser to its customers.
