

Watts A2-IntelliTimer

Installation Instructions

The Watts A2-IntelliTimer is used in conjunction with the Watts IntelliFlow® Automatic Washing Machine Shutoff Valve. It is a remote timer which allows the IntelliFlow® to be used in applications where the washing machine or a combination washer/dryer is 220 VAC powered. (The IntelliFlow® is not compatible with 220 VAC powered appliances). The timer initiates a two-hour cycle when the button is depressed.

The A2-IntelliTimer low voltage power supply is plugged into the IntelliFlow® power outlet. The remote solid-state timer is installed in a location that is convenient to the user and connected to the low voltage power supply.

Activation of the push button on the timer causes current flow, which is detected by the IntelliFlow®. The IntelliFlow® then actuates the solenoid valves, allowing water to flow to the washing machine. This also begins a timing sequence of two hours, which, upon its completion deenergizes the IntelliFlow®, shutting off the flow of water to the washing machine. The timing sequence can be interrupted by activating the push button a second time.

A Green LED is illuminated whenever the A2-IntelliTimer is energized.

Installation:

Read all instructions prior to beginning the installation.

Note: The A2-IntelliTimer should be located close to the washing machine or on the washing machine itself.

Caution: Locate the power cable such that it will not interfere with the washer/dryer doors or be crushed or pinched when opening or closing the doors.

1. Determine the ideal location for the A2-IntelliTimer and check to be certain that there is sufficient cable to allow the low voltage power supply to be plugged into the IntelliFlow® power outlet. (Cable length is 6 ft.)

Caution: Do not attempt to lengthen the power cable in any manner.

2. Mount the A2-IntelliTimer using the double-sided tape or wall anchors supplied with the kit.
3. Insert the plug from the low voltage power supply into the IntelliTimer power jack.
4. Plug the A2-IntelliTimer power supply into the IntelliFlow® power outlet.
5. The green LED should flash. Depress the black on/off button to complete the installation.

Operation:

To activate the water supply to the washing machine, push on the A2-IntelliTimer on/off switch. The A2-IntelliTimer power lamp will be illuminated whenever the IntelliFlow® is on (supply of water is open).

The A2-IntelliTimer will automatically shut off the power to the IntelliFlow® upon completion of the timed two-hour sequence or upon depressing the button a second time. The power lamp will be off. The water supply to the washing machine will be off.

To assure constant water supply when doing multiple loads of laundry, remember when starting a new load to push the on/off switch to reset the timing sequence.

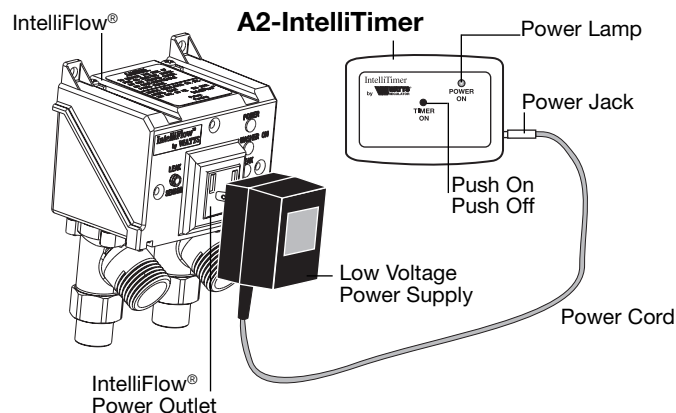
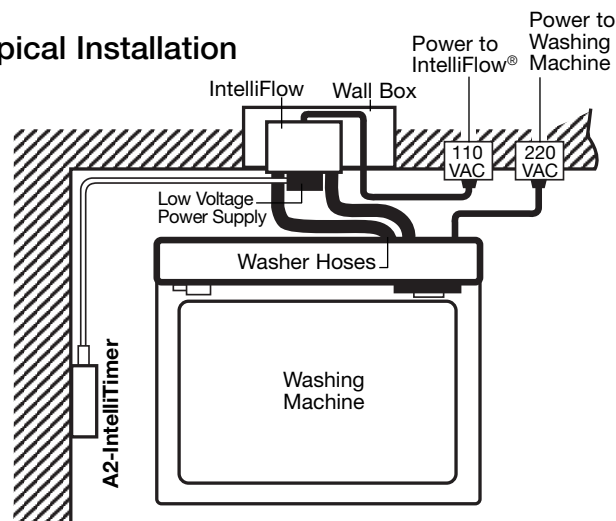
